

Ahmedabad Municipal Corporation, it operates the Bus Rapid Transit Service in Ahmedabad over a dedicated corridor of nearly 100 km through 335 Buses serving around 1.8-2 lakh passengers per day. At present, AJL operates 135 AC ICE Buses and 200 AC Electric buses are operating daily in the system.

As part of the fleet augmentation plan, AMC/AJL intends to purchase **25 (Nos.)** of articulated, 900 mm floor height, 18 mtr length, Electric AC buses that can operate for a minimum 220 km daily with overnight charging and the opportunity for charging for 50-70 mins during the day. The Buses shall have doors with a stepped entry on LHS side and Doors without steps on the wheelbase (wheelbase of the bus and the trailer) on the RHS. Each door shall have an aperture of a minimum 1200 mm and a height of 1900 mm.

Interested National/International manufacturers possessing relevant capabilities may submit their EOI with details of bus specifications, previous experience of supply of articulated and timeline of supply of prototype in a sealed envelope by **05/10/2024** to General Manager, AJL, at above address by **16:00 hrs**.
